# The Pan-Canadian *Clean Growth and Climate Change Framework*: Adaptation Working Group

The international climate change agreement reached last December in Paris created global momentum to act on climate change. In Canada, the government has made action on climate change a priority, mentioning it in at least 11 ministerial mandate letters and pledging hundreds of millions of dollars to support the development and deployment of climate mitigation and adaptation technologies.

To fulfill a campaign promise to hold a meeting with Canada's premiers within 90 days of the Paris conference, the prime minister met with premiers last March to discuss a national climate change plan for Canada. The meeting resulted in the *Vancouver Declaration*, a document that outlined an approach to developing a pan-Canadian framework for clean growth and climate change. The federal government intends to adopt the pan-Canadian framework at a First Ministers' meeting sometime this fall.

In early June, the Adaptation Working Group established under the *Vancouver Declaration* convened a consultation with industry, academics and environmental NGOs on their priorities for an adaptation plan for Canada.

We support the creation of a national adaptation plan that prioritizes the protection of trade infrastructure. We would like the federal government to identify key trade infrastructure and conduct extreme weather scenarios and develop contingency plans. We also recommend establishing a national private/public trade infrastructure committee to guide long-term national infrastructure priorities and share data and we propose an infrastructure bank with an expanded mandate to enhance the quality of Canada's trade infrastructure by incentivizing private funding to support more informed investments.
